We encourage you to participate and to share this survey with others in the Pittsboro community.

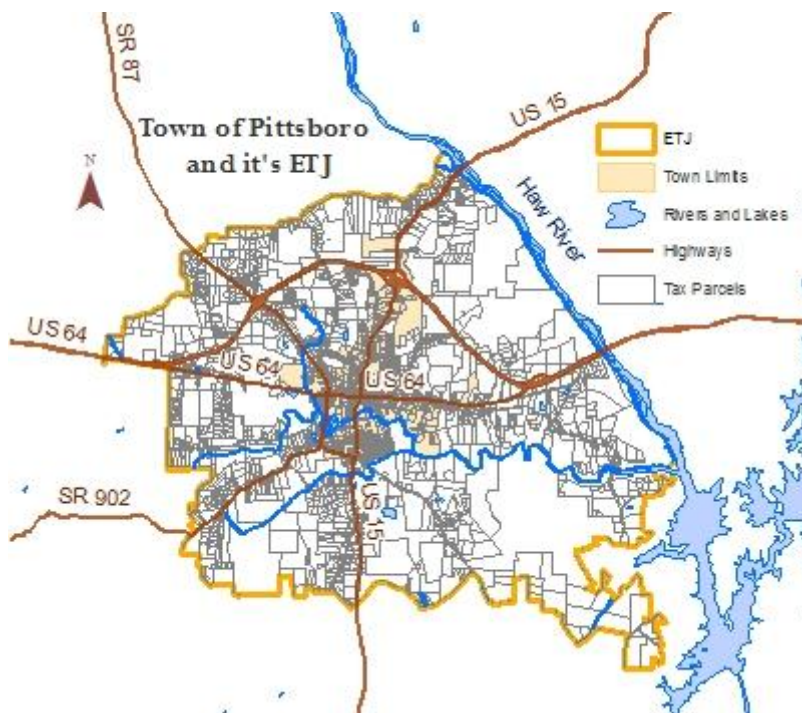

## Conservation Indicators

### 4. Rank the following conservation indicators for **Culture and History** from 1 (most value) to 3 (least value).

Areas of historical significance

Areas of cultural significance

Landscape features, such as key views and vistas

### 5. Rank the following conservation indicators for **Natural Heritage** from 1 (most value) to 3 (least value)

Significant Natural Heritage Areas (SNHA) are areas of water or land with known locations of rare species or rare or high quality natural habitats and are some of the best examples of biodiversity in NC.

Rare or protected species, high quality natural habitats, and special wildlife breeding and wintering habitats (e.g., colonial bird nesting sites)

Cape Fear shiner habitat

[The Cape Fear shiner](#) is a small (approx. 2 inches long), yellowish minnow with a black band along the sides of its body that was listed as endangered in 1987 under the provisions of the Endangered Species Act of 1973. The Cape Fear shiner is native to and only exists in the upper Cape Fear River Basin in North Carolina.

## 6. Rank the following conservation indicators for **Wildlife Habitat** from 1 (most value) to 4 (least value)

Wildlife corridors that provide areas of habitat connecting wildlife populations separated by human activities or structures (such as roads, development, or logging)

Unfragmented forests that provide wildlife habitat

Floodplain forests adjacent to streams and wetlands

Sites that provide essential habitat for one or more species of birds

## 7. Rank the following conservation indicators for **Farmland** from 1 (most value) to 3 (least value)

Voluntary Agriculture Districts

Working farms

Good farmland identified by low slopes and prime farmland soils.

## 8. Rank the following conservation indicators for **Recreation Lands** from 1 (most value) to 5 (least value)

Timberland

Land cover such as tree canopy coverage, impervious hard surfaces (eg. asphalt pavement and rooftops), etc.

Street trees

Unbroken tracts of forest
